**WHEREAS** the settler herein desires to establish a fund solely for the educational purposes and objects and not for purposes of profit and for such purpose has made over a sum of Rs. 5,00,000/- (Rupees Five Lac) only to the Trustees herein by way of initial contribution.

**AND WHEREAS** the Trustees herein have agreed to become Trustees and to hold and apply the said sum of Rs. 5,00,000/- (Rupees Five Lac) only and all gifts, contribution, subscriptions and donations for the said fund for such purposes and subject to the trusts, powers and provisions contained in this deed.

**NOW THIS DEED WITNESS** as follows:

1. The Trustees hereby declare that they and the survivor of them or other Trustees hereof for the time being will hold the said sum of Rs. 5,00,000/- (Rupees Five Lac) only made over by the sellers to the Trustees as aforesaid and all gifts, contribution, subscriptions and donations bequests and other moneys or property as and when the same shall be paid to or vested in them and the moneys investment and property from time to time representing the same upon trust to apply the same for the sole purpose and advancement of education not involving the carrying of any activity for profit in the territories of India, PROVIDED HOWEVER, no part of the fund or income thereof be applied to any purpose outside India except in accordance with the approval of the Central Board of revenue, Government of India.

2. The objects and purposes of the said Trust are as follows:

- (a) To impart, promote and spread education in arts, Literature, science, Engineering, Management and Commerce to the subjects of the union of India in respect of the Minority Section along with other common distress people.
- (b) For the purposes aforesaid to found, maintain, run, manage, supervise, superintend, co-ordinate, affiliate, control, guide and aid paths, alas, schools, colleges, Universities, Hostels, Boarding –houses, Museums, Laboratories, Exhibitions, Libraries, Lecture- halls, Seminar, Staff Quarter, Excursion, Annual Function, Prayer Hall, Distance Education, Vocational Training, Open University, Practical classes, and others Educational Institutions.
- (c) To grant stipends, scholarships, studentship and other concessions or gratuities to deserving students and candidates.
- (d) To obtain recognition affiliation and Government grant from the appropriate authorities and Universities for continuing educational programs and guidelines and holding examination in this regards.
- (e) To hold examinations and to grant certificates of proficiency or other academic distinctions or title to persons who had complied with the conditions laid down in the regulations or bye-laws of the Trust and /or the State Government or any other statutory body set up by such Government.
- (f) To provide facilities offering residential accommodation and boarding house for teachers, staffs and other persons engaged in carrying out any of the objects of the Trust.
- (g) To provide libraries reading rooms for the benefits of students and general public for promoting education.
- (h) To provide any other social welfare activities under the name and banner of Educational Trust such as blood donation camp, Accessories for Physically Challenged Children and people, free eye operation Camp, Disasters Management Camp, project of plantation for free of environment pollution etc.
- (i) To hold any vested land according to the law of land and to receive any kind of donations outside or within the country according to the Income Tax Rules for Trust Act. Only for the purpose of social welfare Activities.

Directly or indirectly by way of dividends, bonuses or otherwise howsoever by way of profit to any person provided that nothing herein contained shall prevent the payment in good faith of remuneration of any offers of servants or employees of the Trust or other person in return for any officers or servants or employees of the Trust or order persons in return for any services rendered to the Trust.

4. The Trust shall be known as ABDUR RAHIM PANCHANAN PAL EDUCATIONAL TRUST WITH POWER TO Trustees to charge the Trust if the Trustees so decided.
5. The number of Trustees shall not be less than two and not more than eleven. The Trustees shall be trustees for their life time but any Trustee may resign by giving notice in writing to other co-trustees and shall also cease to be a trustee if requested in writing by three-fourth of the remaining trustees or the number nearest thereto, Appointment of Trustee either to fill up a vacancy or as additional Trustee shall be by resolution of the Trustee.
6. The general management and control of the trust for the purpose of managing the trust affairs properties and carrying out the objects of the trust aforesaid shall be vested in the Trustees and without prejudice to the generality of the objects and powers above mentioned they shall have power to do all or any of the following things that is to say:
- To enter into contracts and borrow money for the purposes of the trust and management of its properties and assets.
  - To appoint officers and servants at such remuneration (if any) as they think fit.
  - To receive grants, donations and subscriptions.
  - To make such rules and regulations from time to time for the management and conduct of the affairs of the Trust and its properties and assets.
7. The Trustees will also have the following powers:
- To apply the whole or part of the income or accumulation thereof or whole or part of the corpus for the trust properties for one or more of the objects of the Trust as the trustees may from time to time determine.
  - To help, contribute, promote, take over or amalgamate with any other Society, Trust, Body or Institution whether incorporated or not for the objects similar to those of the Trust herein.
  - To declare and give bonus, gratuities allowances to such person who may be employee of the Trust or the families or dependents of such person as may be decided by the Trustees and / or authorized under Law or Income Tax Act. 1961 or statutory modification thereof.

(l) To make, vary, alter or modify schemes rules and regulations for carrying out the objects of the Trust and for the management of the affairs thereof and of running any other educational institution in furtherance to the objects of Trust and otherwise for giving effect to the objects of the Trust.

(m) To set apart the whole or part of the income or the corpus or part thereof for any of the objects of the Trust.

8 (a) The Trustees shall be chargeable only for such money stocks share and funds as shall actually come into their hands and shall not be answerable or accountable for neglect default acts or omission of the other Trustees nor of any Bankers or other person with whom the Trust Properties or any securities may have been deposited or handed over unless caused by their willful neglect or default.

(b) The receipt of the person authorized by the Trustees or a resolutions of the Board of Trustees for any moneys paid or any property transferred or delivered to the Trustees in the execution of any of the Trusts or power hereof or for the purchase moneys of any property authorized to be sole shall effectually discharge any person or persons so paying or transferring or delivering.

9. The Trustees will not be entitled to receive any remuneration as Trustees but may reimburse themselves of all expenses actually incurred by them in connection with the Trust or their deities relating thereto.

10. The Trustees may from time to time frame rules for the conduct of the affairs of the Trust and regulating the meeting of Trustees. In the absence of such regulations.

(a) All matters will be decided by majority and two Trustees shall from a quorum for meeting of Trustees.

(b) Resolution passed without any meeting of the Trustees and evidenced in writing under the hands of three fourth of the Trustees shall be as valid and effectual as a resolution duly passed at a meeting of the Trustees.

11. It is expressly declared that no part of the Trust Property or its income shall be applied for any purpose which is not educational purpose in law and nothing herein shall be considered to authorize the Trustees to utilize the Trust assets or its income for any non-educational purpose. All the powers provisions hereof shall be constructed as being subject to the restrictions and limitation herein contained and contained in prevailing rules and regulations laid down and statutory modification thereof.
